Election - Council consists of 3 elected councillors. As it stands the present Council is looking to step down. Nomination papers are available from the CAO or under Election information on the Village website. More election information is on the Website under Elections. Deadline to submit the nomination paper is 12 noon, July 12th, 2025 at the Firehall. An advance poll will be held August 2, 10am to 12 noon at the Firehall. Election will be held August 9 from 10am to 7pm at the Firehall if required.

There has been an 18% increase in the school requisition, most expenditures have increased slightly. And, most property assessments have increased.

Corn Roast – The annual corn roast will be held Saturday August 23, 11am to 4pm at the Firehall.

Water West – Athabasca County and the Summer Villages are working towards bringing a potable water line from Aspen Regional Water plant to two truck fill stations. One located by the Nine Mile corner and the other at Island Lake. MSI grant funding will be used for this project.

Reserves – An Environmental Reserve adjacent to the bed and shore of any water body is to remain in its natural state or be used as a public park. No personal development is allowed

Fires – Be sure to check the provincial site "albertafirebans.ca/" or watch for signs at Village entrances re Fire bans. Fireworks are not permitted within the Summer Village. This is a provincial regulation.

Landfill Hours – Summer hours: Thursdays 10am – 6pm; Saturdays and Sundays 10am – 5pm. You may wish to check hours of operation. https://athabascaregionalwaste.com

Spring Clean-Up – May 16th to 26th - The Athabasca Regional Waste Management Services Commission (ARWMSC). All transfer sites will waive the fees to ratepayers during normal summer hours for disposing of yard debris including grass, leaves, branches. Tree trunks larger than 6" and stumps are not acceptable at the Transfer Sites
