6.1 Grants

- in the proximity of 1121, Baptiste Dr repair culvert, removal of dead trees, debris from the creek;
- patching from 810 to 816 Baptiste Dr; ;
- 1119 Baptiste Dr; ditching, build a berm, install silt fence as required;
- mail box area install Geotextile, gravel, cold mix. Total cost \$34,500. Work will commence as soon as Alberta First call has identified utilities.
